## KNSW DEALER LICENCE APPLICATION GUIDELINES AND APPLICATION FORM

To facilitate and promote the sport of karting to potential new/temporary license holders, Karting (New South Wales) Inc (KNSW) is issuing a KNSW Dealer License in accordance with KNSW Rules and Regulations. This will allow holders of a KNSW Dealer License to offer a test drive in accordance with KNSW's Come & Try Conditions as specified in KNSW Rules and Regulations.

## Eligibility

## You must:

- Be at least 18 years of age
- Be considered fit and proper for the purpose of the license (NSW Fair Trading and Working with Children records)
- Not be disqualified from holding any KNSW License as a result of disciplinary action
- Not be bankrupt
- Have sufficient financial resources to carry on your business in accordance with the requirements of Fair Trading
- Conduct business from a shop front, truck, trailer, or other physical location
- Have a regular physical presence in and around kart circuits and kart racing events

- Registered Business Name
- ABN
- Working with Children Check
- Completed Application Form
- Payment of Application Fee

#### Guidelines

- 1. Holders of a KNSW Dealer License will be authorized to conduct Come & Try Activities in a specified calendar year, in accordance with Section Y- of the Karting (New South Wales) Inc Rules.
- 2. A logbook record acceptable to KNSW must be maintained by the dealer at all times with records being made available by the dealer to KNSW within seven (7) days of KNSW's request.
- 3. In accordance with Section Y of the KNSW Rules and Regulation, Dealers are required to ensure that all drivers/participants comply with Section Y of the KNSW Rules and Regulations (including all completion of all disclaimer forms and wearing of safety apparel).
- 4. If the driver/participant is under eighteen (18) years of age, then their Legal Guardian and the driver/participant must both sign the relevant disclaimer.
- 5. KNSW Licensed drivers are <u>not permitted</u> on the track at the same time as a Come & Try activity.
- 6. The Dealer acknowledges that it will keep all documentation (including signed disclaimer and other logbook record) for a period of six (6) years.
- 7. KNSW would also require that all KNSW Dealers comply with KNSW Recommendations to Reduce Covid-19 (Coronavirus) Risk as applicable from time to time.
- 8. The Dealer will also comply with all other reasonable directions of KNSW as required from time to time for the efficient, safe and good spirit of karting in New South Wales.
- 9. The Dealer acknowledges that KNSW has the right to suspend or cancel a Dealer License should the Dealer not comply with KNSW Rules, Regulations and Guidelines issued from time to time or if, in KNSW's sole determination form the view that the Dealer does not appropriately represent the sport of conduct themselves in a proper and professional manner.

#### Insurance Requirements

Dealers issued with a KNSW Dealer License are authorized by KNSW to conduct Come & Try Activities as outlined in the KNSW Rules and Regulations and therefore are covered by applicable KNSW Insurances when conducting such authorized Come & Try activities.

#### General Information

- 1. Holders of a KNSW Dealer License acknowledge that failure to abide by these guidelines always could render them responsible should any accidents, incidents or injuries occur.
- 2. The cost of the KNSW Dealer License is set out in the KNSW Fee Structure.
- 3. For 2024, the KNSW Dealer License Fee shall be \$350.00 plus GST per calendar year payable on a pro-rata basis.
- 4. Payment is to be made upon application and then will be invoiced annually (for the full amount of \$350 plus GST) in January of each year.
- 5. Holders of a KNSW Dealer License are not granted automatic access to any KNSW Approved Circuit. Dealers are required to arrange, co-ordinate and comply with any KNSW Club that conducts racing events at a KNSW Approved Circuit. This includes (a) notifying the KNSW Club of their intentions and make appropriate bookings; (b) pay any applicable hire fees for the track and/or facilities; (c) comply with all KNSW Club Rules and reasonable directives. All such access is negotiated directly between the Dealer and KNSW Club. KNSW is not involved, nor responsible for any such agreements relating to track or circuit access.

### **Application Process**

Applicants are to provide all necessary documentation in addition to payment of the Application Fee to KNSW.

All Applications will be determined by the KNSW License Review Committee. The Committee may require additional information or request an interview to assist with their review of an application. All decisions made are final and not further correspondence shall be entered.

In the event an application is denied, the Application Fee will be refunded to the Applicant.
